

**TERMS AND CONDITIONS REGULATING THE USE
OF THE MOBILE BANKING APPLICATION “GEORGE GO”
DURING THE PILOT OPERATION**

1. To participate in the pilot operation of the George Go mobile application, you must first electronically accept the terms and conditions of its use.
2. The participant of the pilot operation may be a client of Česká spořitelna, a.s. (hereafter the “Bank”) – consumer with a Contract on provision of the SERVIS 24 service and active electronic banking.
3. The same combination of the client number and password as for the SERVIS 24 Internetbanking application applies for registration (the first logging) into the George Go electronic banking application. For your registration you can also use the banking identity if it was assigned to you. After the successful registration you shall select the way which you shall use to log into the application (depending on the operating system of the utilised telephone - gesture, PIN, fingerprint or lock of the telephone).
4. The pilot operation takes place on your real account and with real money. Please hereby note and agree that as part of the pilot operation, until the next update of a document Information of Česká spořitelna, a.s. on payment services – Private Clients (hereafter the “Payment Services Information”) comes into effect, the set maximum transaction limit for authorisation by the text messaging method is CZK 200,000 daily.

In addition, please note that this limit is not included in the negotiated limit for transactions in the SERVIS 24 Mobile Bank and SERVIS 24 Internetbanking applications. Therefore the total daily transaction limit via electronic banking consists of the total limits for applications SERVIS 24 Mobile Bank, SERVIS 24 Internetbanking and for the George/George Go services.

5. With respect to provisions 3 and 4 you pledge to observe all and any security rules for electronic banking services stipulated in the General Business Terms and Conditions of Česká spořitelna, a.s. – private clients.
6. The Bank is authorised to make changes to the contents of the application as part of the pilot mode and during its course. We will notify you of changes to the pilot contents of the application by means of the Bank’s communication channels such as the web pages, e-mail or directly in the application.
7. You are not authorised, in any way whatsoever, to try to breach the environment of electronic banking for security and business reasons. You pledge not to produce any visual documentation of the application and to act in a manner so as not to breach the Bank’s trade secrets or copyrights.

8. You accept these terms and conditions for an unlimited period. The Bank may terminate the pilot operation, or exclude you without giving any reasons or prior warning.
9. Voluntary participation in the pilot operation takes place from 23 April 2017 for an unlimited period and without entitlement to remuneration.
10. The prices within the pilot operation are applied according to the Bank's valid price list and are identical as those applied for applications SERVIS 24 Internetbanking and Mobile Bank.
11. The Bank is authorised to contact you for the purpose of informing or obtaining feedback as part of this pilot operation.
12. You can end your participation in the pilot operation by sending a request to the e-mail address george@csas.cz. The Bank is obliged to meet this request in the shortest possible period.
