The Bank may charge an additional fee for account management (current account or other type of account) at the rate of 0.15 % from Increased balances\* to 31 December. If the sum of Balances on client accounts to 31 December\*\* given year exceeds CZK 100 million and will be higher than Average balances\*\*\* in a given year. The fee can be charged from any client account maintained by the Bank till 31. 3. of the following year.

The Bank may charge at the end of the month additional fee for account management (current account or other type of account) at the rate of 1 % p. a. from average monthly balance on all accounts in EUR currency where balance is over EUR 1 million.

- \* Increased balances: the difference between the balances on client accounts to 31 December\*\* and average balances\*\*\*.
- \*\* Balances on client accounts to 31 December: The sum of final balances in all accounts and term deposits (deposit accounts) converted into the currency CZK by central rate of the Czech National Bank to 31 December given year. Any negative balances will be replaced by zero.
- \*\*\* Average balances: Average total of the final balance on all client accounts from 1 January to 30 November of a given year converted into the currency CZK by central rate of the Czech National Bank as of 31 December of that year plus the total of the average balances of time deposits (deposit accounts) client from January to November (always as of the end of the respective month) of the year, converted into the currency CZK by central rate of the Czech National Bank as of 31 December given year.
